## MINUTES OF THE WINNEBAGO CITY COUNCIL

City of Winnebago

Special Meeting June 3<sup>rd</sup>, 2013

A regular meeting of the Winnebago City Council was held on Monday June 3rd, 2013 at 5:00 p.m. in the Municipal Center Council Chambers.

Mayor Schutt called the meeting to order and conducted roll call. Council members present: Johnson, Robertson, Anderson. Staff Present: City Administrator Ziegler, City Attorney: Douglas Johanson.

Motion by Anderson, seconded by Johnson to approve the proposed meeting agenda of June 3, 2013 with the addition of a presentation by Linsey Warmka of Faribault County Development Corporation. Mayor Schutt called for a vote. The following voted in favor: Johnson, Robertson, Anderson. Motion carried.

### Public Coment

Mayor Schutt opened the meeting for comments from the public. There were no comments. Mayor Schutt closed the meeting to public comments.

### General Business

#### Vacant Council Applicant Interviews

Robert Perryman was present for an interview. The Council asked questions from the distributed list of interview questions. The Council thanked Perryman for his interest in the position. Jonathan Weerts was not present, so Mayor Schutt proceeded to the next agenda item and continued the interview when Mr. Weerts arrived.

#### Resolution 550-2013 – Craft BrewFest Bill

Motion by Johnson, seconded by Anderson to approve Resolution 550-2013 affirming the special State law for Craft Brew Fest. Mayor Schutt called for a vote. The following voted in favor: Johnson, Robertson, Anderson. Motion carried.

Vacant Council Applicant Interviews - continued

Jonathan Weerts arrived for his interview. The Council asked questions from the distributed list of interview questions. The Council thanked Weerts for his interest in the position. Ziegler then distributed the voting forms. Council Members discussed the interviews and their feelings regarding each candidate. Mayor Schutt and Council Members then wrote down their votes and Mayor Schutt collected the voting forms.

Linsey Warmka FCDC – Veteran’s CBOC

Linsy Warmka informed the Council about an Economic Development opportunity for a Veteran’s Clinic at a site in Winnebago. She asked for a letter of support from the Council. Motion by Johnson, seconded by Anderson to approve a letter of support for the project. Mayor Schutt called for a vote. The following voted in favor: Johnson, Robertson, Anderson. Motion carried.

Appoint New Council Member

Mayor Schutt informed the Council he had tallied the voting forms. Four votes were received for Jonathan Weerts as first choice. Four votes were received for Robert Perryman as second choice. Motion by Johnson, seconded by Anderson to appoint Jonathan Weerts to the vacant City Council seat. Mayor Schutt called for a vote. The following voted in favor: Johnson, Robertson, Anderson. Motion carried.

Other Business

Council Members and Mayor Schutt asked Ziegler about procedures and status regarding nuisance properties in the City.

Adjournment

Motion by Robertson, seconded by Johnson to adjourn the meeting. Mayor Schutt called for a vote. The following voted in favor: Johnson, Robertson, Anderson. Motion carried.
